## **WARRANTY CONDITIONS**

NDS ENERGY S.r.l. warrants its Photovoltaic Modules 24 months for any materials and manufacturing defects excluding cases derived from wrong installation, use and storage.

The warranty starts from the date of sale to the customer, as indicated in the attached coupon or invoice. In case of failure of PV Module, the customer can contact an Authorized Service Center or directly to NDS ENERGY which, after investigation and testing, will decide whether to replace or restore the functionality of the same Module. In case of replacement, the warranty expiration remains the initial.

The warranty is valid provided that the Module was used in the correct manner and must not be tampered with. If the customer decides to further verification by third technical part shall support personally the costs, without demanding anything from NDS ENERGY S.r.l.

## **EFFICENCY WARRANTY**

### **Limited Peak Power Warranty – 12 and 25 Years**

If, within a period of twelve (12) years from the date shown in the invoice and warranty coupon to the Customer any Module exhibits a power output less than 90% of the minimum “Peak Power at STC” (Standard Test Conditions).

The actual power output of the module shall be determined for verification using Standard Testing Conditions only. The actual power output measurement is either carried out by a NDS ENERGY facility or by a NDS ENERGY recognized 3rd party testing institute. Testing equipment tolerances will be applied to all actual power output measurements.

If, within a period of twenty-five (25) years from the date shown in the invoice to the Customer any Module exhibits a power output less than 80% of the

minimum “Peak Power at STC” (Standard Test Conditions).  
The actual power output of the module shall be determined for verification using Standard Testing Conditions only. The actual power output measurement is either carried out by a NDS ENERGY facility or by a recognized 3rd party testing institute. Testing equipment tolerances will be applied to all actual power output measurements.

### Exclusions and Limitations

The Limited Product Warranties and the Limited Peak Power Warranties do not apply to any Modules which have been subjected to:

- Misuse, abuse, neglect or accident.
- Alteration, improper installation or application.
- Non-observance of NDS ENERGY’s installation and maintenance instructions;
- Repair or modifications by someone other than an approved service technician of NDS ENERGY;
- Power failure surges, lightning, flood, fire, accidental breakage or other events outside NDS ENERGY’s control

The two Warranties do not cover any transportation charge, customs clearance or any other costs for return of the Modules, or for reshipment of any repaired or replaced one, or costs associated with installation, removal or reinstallation of the PV Modules.

Warranty claims will not be honored if the type or serial number of the Modules have been altered, removed or made illegible.  
Any color change on module or any other changes on module appearance do not represent defects, insofar as the change in appearance does not stem from defects in material and/or workmanship, and does not cause degradation of functionality of the module, which are exempt from this warranty.

### Dispute

In case of dispute, the court of competent jurisdiction will be the court of Pescara (Italy)
